3. THE OBJECT OF THE TRUST IS:

- a. - b. To establish and support the professorship, fellowships, lectureship, scholarship, loans and scholarship and at any schools, colleges or other educational institutions in India.
- c. To establish and maintain hostel boarding house and grants for free boarding and lodging to poor deserving students and other persons upon such terms and for such period in each case as the TRUSTEES may think fit.
- d. To take-over the management and administration of educational and culture institutions of the aforesaid nature and orphanages already established with all assets and liabilities.
- e. To construct, establish, maintain, manage laboratories, workshops and undertake, conduct, carry on or help to carry on scientific research and other scientific works and to provide fund for such work or for payment to any person or persons engaged in research work whether in such laboratory or elsewhere in the fields of natural or applied sciences including agriculture or animal husbandry, imparting education, acquisition of knowledge.

h. MEDICAL RELIEF:

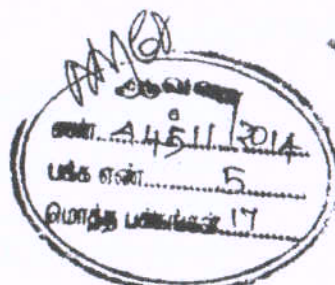
To afford medical relief in such manner as the TRUSTEES may think fit:

i. RELIEF TO THE POOR: GENERAL PUBLIC UTILITY

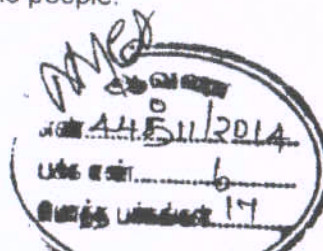
To Pursue, implement and carry on any of the following objects if and only if it can be termed as charitable as defined under Income Tax Act, 1961 on any statutory modification /s thereof and to use the funds of the Trust for fulfillment of following objects:

- a) To distribute free food and clothing and outright grants to the poor and needy.
- b) To sink wells wherever and whenever and there is scarcity of water.

- c) To subscribe, contribute and/or donate to any public fund or institutions established for promotion of public charitable purpose with such conditions as the Trustees shall think fit.
- d) To establish, promote, institute, support, develop, encourage various institutions, and centers, funds, trusts, academic associations for the purpose of in aid or, in prosecution and promotion of all expressions of arts ,all branches of sciences (contemplative or applied)and technology, cultural centers ,and advance/advancement of any carrying on of any activity for profits.
- e) To promote, encourage and advancement of physical education and training and /or physical efficiency of the members of the public.
- f) To Sponsor ,undertake establish and execute any Trusts, endowments and funds for the purpose or providing relief on occasions of national and /or natural calamities like earthquake, fire, riots, tornadoes, famines, epidemics floods, war, warlike operations or for other purpose/s which may seem describe by the Trustees and which may be considers charitable.
- g) To institute, finance, encourage, prosecute, develop and carry on, without involving the carrying on of any activity for profit, all kinds of scientific, economic and technological research, research, research relating to trade, commerce and industry, and also research in social, cultural. Behavioral and human science.
- h) To promote, establish and maintain or help by monetary gifts or otherwise social and cultural and health centers including recreation grounds, play fields play grounds, swimming pools and public gardens.

- k) To institute a free legal cell consisting of experts for the benefit of poor and downtrodden and provide all free legal assistance to the people.

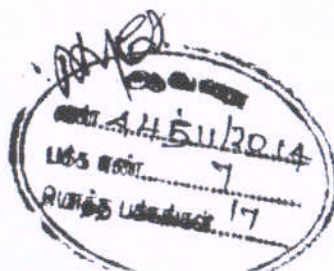

j. RURAL DEVELOPMENT:

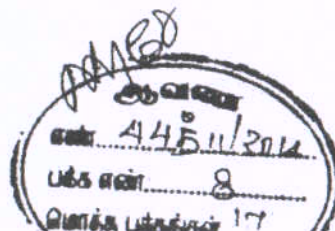
To undertake, carryout, layout, promote, sponsor or assist in any activity and programme for rural development including any programme for promoting the social and economic welfare of or the uplift of the people in any rural area in India. To incur and expenditure or use or apply any of the assets and specialist of the Trusts on any programme or rural development and to assist execution and promotion thereof either directly or in association with any company or person /s or organization or through an independent agency or in any manner as the Trustees may deem fit and the Trustees may at there discretion in order to implement any of the projects of programme of rural development of transfer with or without consideration or at such fair or confessional values as they in their own discretion think fir and divert the ownership of the property to or in favour of any public or local body, authority, central or state Government or any public Institution of Trust or fund as the Trustees may deem fit necessary, without prejudice to the generality shall inter also include:

- a) Assistance in the setting up of rural Industries in selected areas by the rural weak to provide them self-employment.
- b) Establishment and running of dispensaries, maternity and child welfare centers and family welfare centers.
- c) Nutrition programmes for school children.
- d) Construction and maintenance or rural link, roads, village street, pavements and drainage.
- e) Establishment and running of educational and vocational training centers.
- f) Construction and maintenance of drinking water projects such as wells, tube wells etc., and clearing of wells and ponds.
- g) Rural electrification i.e.,provision of street lighting in villages and electrification of Harijan/Tribal houses.
- h) Assistance to the weaker sections of Trust in construction houses at sites provided in rural areas by Government, Village, Panchayats etc.,
- i) Minor Irrigation Schemes including Boring or Tube and installation of pumping sets for the benefits of groups of small or marginal farmers.

- j) Supply of improved varieties of seeds and provisions of facilities for seed testing to groups of small /marginal farmers and assistance to such farmers for establishing seed farms.
- k) Supply of fertilizers and insecticides to groups of small /marginal farmers and giving guidance and training to such farmers in the use of fertilizers, insecticides etc.,
- l) Supply of plant protection equipment, sprayers, farm machinery, implements etc., to the village Panchayats for the use of groups of small/marginal farmers.
- m) Assists the farmers in improvement of cattle, through establishment of veterinary dispensaries, artificial insemination centers etc., in dairy products processing and marketing.
- n) Assistance to groups of small /marginal farmers, landless labourers etc., in poultry farming, horticulture, Pesticulture etc.,
- o) Establishment of workshop for servicing and repair of farm machinery and training of artificians, mechanics etc., or any other programme for promoting the social and economic welfare or the uplift of the people in any rural area which in the opinion of the Trustees is likely to promote and assist rural development and that the word "Rural Area" shall include such areas as may be regarded as rural areas under the provisions of Income Tax Act, 1961 or any other law in force for time being, relating to rural development or which in the opinion of the Trustees may be regarded as rural areas.
- k. To undertake, carryout, promote, sponsor or assist in any activity which in the opinion of the Trustees are likely:
- a) To promote national welfare or social economic or moral uplift of the Trust people of any section of the Trust. And
- b) To promote and improve national economy in such manner and by such means as the Trustee may think fit.
- i. To apply the income and funds of the Trust for the advancement of any other objects of general public utility not involving the carrying on of activity for profit. Provided that every contribution (whether from income or corpus or both) by Trustees to any other trust. Trust or institutions, fund scheme or object having as its sole object all or any of the aforesaid public charitable trusts and objects shall have treated and be deemed to be in furtherance and



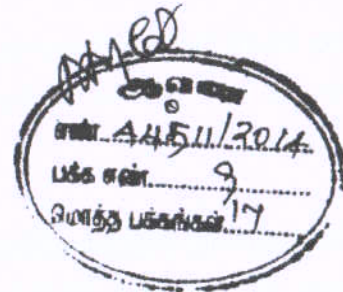

Provided Further that notwithstanding anything contained herein above the Trustees shall have an absolute power by deed interweave or such other documents as may be necessary to delete any of the objects or provisions or any part of the aforesaid Trust which are found contrary to the concepts to the public Charitable purposes or the provisions of any law relating to the public charities in India and without violating the provisions of income Tax Act, 1961, relating to Charitable Trusts.

- a) The Board of Trustees shall be the lifetime Trustees unless in their uncontrollable discretion feels that it shall be transferred to any other persons of their lineage. The Trustees shall have power by majority to co-op. to any person as a Trustee who shall hold office till such time the life Trustees agree by majority from time to time.
- b) In the event of any of the trustees dying without nominating his/her successor his/her lineal decedents will be the Trustees until such time he divests himself of trusteeship. After his time the rule of seniority of lineage will prevail. In case no son is born the senior most daughter and her lineage will prevail.
- c) In any case a Trustee mismanages the Trust funds, the majority members who have attained majority can remove the Trustee from Trusteeship and appoint the senior the senior the senior most son or daughter as per supra to fill up the vacancy.

o. MANAGEMENT:

The day to day conduct and management of the Trust shall be carried out on by **Mr. B. ANBU**, who shall be known as the **Managing Trustee**. He shall be the Managing Trustee till his life time or until he chooses his successor to be the **Managing Trustee**.


4. THE MANAGING TRUSTEE SHALL HAVE THE POWERS:


- a) To receive and keep all trust funds and monies by way of Gifts, donations, contributions, borrowings, and grants and other assets of the Trust:
- b) The Managing Trustee cum chairman, Secretary cum correspondent shall have the power to open bank accounts in the name of the trust in any nationalized banks/post office/Co-operative banks/Private banks and to operate jointly.
- c) The **Trustee** shall have the power to appoint or terminate such and employed to carry out the object of the Trust.

5. SECRETARY:

The **Secretary** shall maintain the records of the organization prepare and circulate agenda and minutes of Board of Trustee meeting for the approval of the Managing Trustee.

The Secretary shall be also responsible for the day to day administration activities of the Trust. The Secretary shall deal with correspondence received by the Trust, send replies

in consultation with the Managing Trustee, Vice President and/or the Treasurer where necessary. He/she is responsible for the safe custody of all the properties and records of the Trust. The Secretary shall represent the Trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the Trust in Government offices.

6. TREASURER:

The **Treasurer** will prepare Annual Budget, monthly and yearly expenditure statements get the expenditure audited by auditor duly appointed by the Board of Trustees and place them before the Board of Trustees for approval. The Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts or articles received by the Trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval. The Treasurer is responsible for safe custody of cash, bonds, securities etc. of the Trust.

7. The trustees shall be entitled to invest the trust monies according to their discretion either with banks or post offices or Co-operative banks or the first mortgage of immovable property or purchase of immovable property.

1. The Trustees shall have power to borrow within reasonable limits, from time to time, in the ordinary conduct of the Trust if in their opinion, it is necessary to borrow for the furtherance of the objects of the Trust by mortgaging or charging the properties.

2. The Trustees shall not be entitled to any remuneration or benefits either by way of sitting fees, or otherwise for service rendered as Trustees but they will be entitled to be paid such reasonable Travelling Allowance and Boarding expenses as may incurred by them for attending the meeting of the Trust and the sums to be so paid shall be decided from time to time by the Board of Trustees and will be payable out of funds of the Trust.

3. The Trustees shall keep true and correct account of all trust monies and the disbursement thereof and the accounts shall be closed on 31st March every year and Audited by a Chartered Accountant duly appointed and approved by the Trustees, six from closing.

4. No immovable property is involved in this Deed of Trust.

4 (a) There is no movable and immovable property for this Trust.

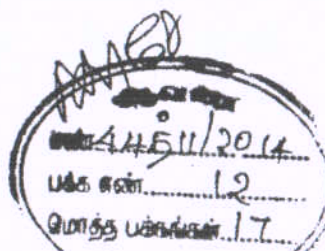

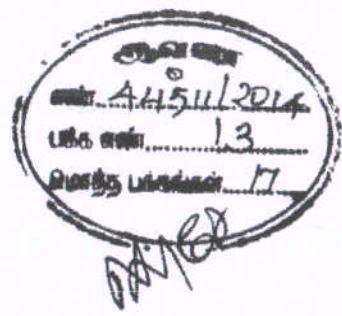

 - ix. It is hereby declared that the trust formed for fulfilling the objects of the trust and shall be irrevocable.

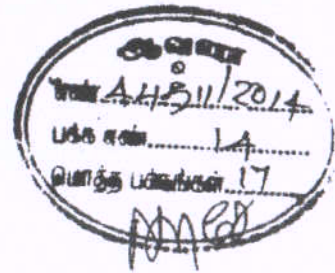

